MESSAGE FROM OUR MINISTER - Rev. Peggy Meeker
Reflections on June

For Unitarian Universalist congregations across the country, June brings two very special events, Flower Communion and General Assembly.

Flower Communion, which for three years now we’ve celebrated on the last regular Sunday service of the church year, is a simple but beautiful honoring of our unity, our diversity, and our community.

General Assembly, or GA, isn’t something we’ve thought a lot about at BUUF. People may know that GA is where the business of the Unitarian Universalist Association (UUA) is done, and that the Assembly chooses issues for congregations to study—the current topic being Immigration as a Moral Issue—but until now, BUUF didn’t play a role in any of that because we didn’t officially belong. Now that’s changed!

Because we became affiliated with the Association last fall, we are eligible to send two delegates, and Karen and Bernie LoBracco will be attending and voting. As the minister, I get to vote too, and I’ve registered to “attend” via computer. Even more exciting, there’s a wonderful banner parade at the opening ceremony, and a small group of BUUFians is working hard to create our banner. If it’s ready in time, it will be displayed at our June 17th service, and judging from the sketches, it’s going to be gorgeous.

But there’s more! As one of three new congregations to join the UUA this year, our delegates get to stand on the stage during the ceremony and accept the congratulations and best wishes of a crowd of several thousand UUs. And according to the GA website, that opening celebration, starting at 7:30 p.m. on Wednesday, June 20, “should” be available via live-streaming on UUA.org. I hope so, because I’m really looking forward to seeing this!

Bring a flower for flower communion, and bring a friend or family member (or several), and let’s savor the special moments that June will bring to our faith community.

"UUA Considers Relocation"

“25 Beacon Street” has been synonymous with UUA Headquarters since 1961, and with Unitarian Headquarters since 1927. The location is historic and prestigious (immediately adjacent to the Massachusetts State House), but not very practical. To start with, there isn’t enough space, so half the staff is located a long block away at 41 Mount Vernon St. Both buildings are old and dark, and only partially accessible to visitors and staff with disabilities. The Mount Vernon address lacks fast Internet access. Needed repairs and improvements are expected to total nearly \$10 million over the next few years.

At the same time, the Boston real estate market is badly depressed at the moment—everywhere other than Beacon Hill. Selling the current facility (including a 20-room Bed & Breakfast located between the two administrative buildings) would raise sufficient funds to purchase estimated \$10 million left over to add to the UUA endowment.

The UUA has considered moving before—most recently one year ago, when it placed a preliminary bid on space being sold by Hebrew College in the western suburb of Newton. When the Hebrew deal fell through, denominational leaders undertook a highly detailed study of current and future building needs. The resulting report (available at www.uua.org/documents/leapfaith/120402_spff.pdf) was received and approved by the UUA Board of Trustees at its meeting in late April.

New quarters have not yet been identified, but the requirements are clear. A candidate site can be expected to bring all staff together in one building, with an open office plan, lots of natural light, excellent accessibility, and wiring appropriate for modern office equipment. Like the current location, it will need to have easy access to mass transit. Unlike the current location, it can be expected to be energy efficient and to have at least a bit of room for parking.

June 2012 Newsletter**BUUF BOARD MEETING MINUTES - MAY 17, 2012**

The meeting was called to order at 7:15PM. The Chalice was lit, followed by Check-in.

Attendance: President Don Zimmer, VP Jim Foote, Treasurer Bernie LoBracco, Secretary Cora Schrader, Trustee Carol Taillie, Asst. Secretary Jean Sauberan, Minister/Advisor Rev. Peggy Meeker, Guests George Miller, Ron Beiswenger, Bill Clifford.

The Minister's, President's and Financial monthly reports were received via email prior to the meeting.

GOVERNANCE BRIEFING - Peggy Meeker and Don Zimmer

- Peggy and Don presented material about "Rethinking Board Leadership", by Ron Hotchkiss. A brief discussion followed about revamping the agenda to fit UU church needs and how this would better facilitate each meeting.
- Peggy recommended a board orientation. Cora Schrader suggested a time, June before the first meeting of the new board. Jim Foote will organize and coordinate a board "brainstorming" group before the June board meeting.

POLICIES AND PROCEDURES BRIEFING - George Miller

- George handed out an organizational chart he created. He briefly reviewed the document and explained his reasoning.
- George prepared a committee/team policy and procedure form. A detailed list of proposed committees, and the person currently handling the related responsibilities, accompanied the form. Each listed person will receive a copy to use in completing the policies and procedures information. This is necessary to avoid current and future confusion. The referenced people present at the meeting received his/her document. The remaining forms were given to board secretary, Cora Schrader. She will deliver them.

SURVEY DOCUMENTS - George Miller

- George handed out a questionnaire and a document from the Worship committee. He will distribute forms to BUUF members and friends to complete and return by June 17, 2012. This information will guide the new board in establishing the future direction of the congregation and the necessary planning to accomplish this.

FINANCIAL BRIEFING - Bernie LoBracco, Don Zimmer

- Bernie reviewed the financial statements. Paper copies were given to board members needing them.
- Bernie stated an unexpected grant of \$4,630.00 was received from the Chalice Lighters. One of the congregational resolutions will commit the Finance committee to submit a revised budget within six months.
- Don briefed the board on the importance of having a Financial Committee, separate from the board. Don held a meeting with Cora, Ron, George, and Bernie to discuss creating a financial committee to help with the new budget.
- Don made a motion, seconded by Carol, to create a Financial Committee, headed by the BUUF treasurer with four other members. The motion was passed. This years committee will include: The Treasurer, Bernie, Ron, George, and one other.

ANNUAL CONGREGATIONAL MEETING BRIEFING - Don Zimmer, Bernie LoBracco, Ron Beiswenger

- The annual congregational meeting will take place on Sunday, May 20, 2012 after the regular worship service.
- Don mailed the congregational meeting packet before May 5, 2012, providing more than the required 15 days before the May 20th annual meeting. The packet included the nominees for 2 trustees and the treasurer, 2 resolutions, proposed budget, agenda, and the new Chalice Lighters grant information.
- It was determined that 12 members needed to be in attendance to meet the quorum requirement stated in the by-laws.
- George Miller will preside over the annual congregational meeting.
- Cora Schrader, board secretary, will take and report the annual congregational meeting minutes, count those in attendance, and determine if a quorum has been met. A second person will verify this information.

SOCIAL JUSTICE REQUEST - Don Zimmer

- Don Zimmer made a motion, seconded by Jim Foote, to give \$250.00 to the Brockport Water Project for Sudan and \$100 to the Food Shelf for the backpack program. The motion was unanimously passed.

MINISTER EVALUATION AND SALARY DISCUSSION - *Closed Session*

The next board meeting will be Thursday, June 21, 2012, at the Garland Church. The Chalice extinguished.

ANNUAL BUUF CONGREGATIONAL MEETING – MAY 20, 2012

The meeting was called to order after the Sunday worship service. The Chalice was lit.

Attendance was taken by Cora Schrader, Secretary, Board of Trustees, and verified by Jean Sauberan, Assistant Secretary. A quorum of 12 members must be present. There were 20 members in attendance.

Don Zimmer, President, Board of Trustees, welcomed members and guests present. He then turned the meeting over to George Miller.

George Miller passed out the ballots to the congregation members. The candidates were identified: 2 Trustee candidates for 2 open positions, 2 years – Carol Taillie, Bill Clifford; 1 Treasurer for 1 position, 1 year – Cora Schrader.

A member asked why the Treasurer's position was only for one year. Don Zimmer asked Ron Beiswenger, as one of the By-Laws creators, to explain why.

Ron also explained the second resolution about the 2012/2013 6-month budget. There were no additional questions concerning the proposed 6-month budget.

Don Zimmer explained the first resolution concerning carryover Social Justice funds from the 2011/2012 budget. There were no questions.

George Miller discussed a Worship Committee Survey along with a Budget Survey. George, Ron, and Jean Sauberan distributed the surveys to those present. George requested that the survey be returned no later than Sunday, June 17, 2012. Jerry and Barb Mitrano will evaluate the responses and report the results to the board of trustees.

The Chalice was extinguished.

After the votes were counted, the results were reported during the refreshment time after the congregational meeting. Both resolutions passed. The nominees, Carol Taillie, Bill Clifford, and Cora Schrader, were elected.
